

Use Platform Filters

- Alignment between business model and impact
- Ability to scale without diluting purpose
- Transparency in reporting both financial and impact results


Strategic Advantages of Impact Startups

Access to partnerships with established non-profits that can accelerate market entry and adoption.


Public Grants


